## Precincts Standing Advisory Committee – Referral 1: Fishermans Bend Infrastructure Funding Planning Scheme Amendment

On 30 April 2024, the Committee advised parties of its decision to grant an adjournment of the Hearing set down for 27 May 2024 until 14 October 2024 (at the earliest). The Committee further advised it would convene a third Directions Hearing as soon as possible to consider revised Hearing dates and directions for the conduct of the Hearing.

Parties were directed to advise Planning Panels Victoria of their availability in the weeks of 6 May, 13 May and 20 May for a third Directions Hearing.

## **Directions Hearing**

After considering the availability of parties and the need to have the Directions Hearing as soon as practical, the Committee advises the third Directions Hearing will be held in person and online:

Parties should allow two hours for the third Directions Hearing.

The Committee also directed parties to advise Planning Panels Victoria and the parties in writing at least two business days before the third Directions Hearing of:

- any concerns with DTP Precincts' proposed timetable and procedural steps set out in Harwood Andrews' letter dated 29 April 2024, along with proposed alternatives
- any further directions the parties intend to seek
- availability constraints between 14 October 2024 and 20 December 2024 for a reconvened hearing.

As a result, the above matters must be advised no later than 12noon, Monday 6 May 2024.

The Committee proposes to issue further directions after considering all requests and any additional matters raised at the Directions Hearing or in writing before the Directions Hearing.
